## *The U.S. Department of Energy Announces Extension of the Public Comment Period for the Draft Environmental Assessment for the Acceptance and Disposition of Spent Nuclear Fuel Containing U.S.-Origin Highly Enriched Uranium from the Federal Republic of Germany to March 25, 2016*

On January 25, 2016, the Department of Energy (DOE) issued a Notice of Availability (NOA) of its draft Environmental Assessment (EA) (DOE/EA-1977) evaluating the potential environmental impacts from a proposed action to receive, store, process and disposition spent nuclear fuel (SNF) from the Federal Republic of Germany at DOE's Savannah River Site (SRS) (Draft Spent Nuclear Fuel from Germany EA). In that previous Notice, DOE invited public comments on the Draft Spent Nuclear Fuel from Germany EA and announced a public meeting for February 4, 2016. DOE advised that the public comment period would have a duration of 45 days from the date of publication of the NOA, with comments to be accepted by the Department until March 11, 2016. Several requests were received from the public to extend the public comment period. DOE has evaluated those requests and is extending the public comment until March 25, 2016.
